## Even Though In pandemic Era, the Total Regional Income in Pangandaran Still Incrreases

PANGANDARAN WEST JAVA - Even though during the Pandemic Civid-19 era, it turns out that the total regional income Pangandaran regency continues to rise.

The fact of this increase is taken from a provisional calculation that refers to the revenue realization data in the 2020 fiscal year, in which the Pangandaran

regency regional expenditure budget has actually increased," said the head of the regional financial management agency, Drs Hendar Suhendar MSI, in his office, Tuesday 05/01/2021.

He said that, with the covid-19 pandemic, this certainly had a huge impact on the regional financial condition, as well as the financial condition of the regional budget, which of the several income sectors that had been the mainstay of this had actually decreased.

Revenue in the APBD, there are three posts, namely: 1. Local Own Revenue (PAD), 2. Transfer Funds and 3. Other income is legitimate, however, local revenue and transfer funds have indeed decreased compared to 2019," he explained.

In more detail, Hendar explained that, PAD in 2020 decreased by 8.4% or 9.9 billion rupiah, compared to 2019, yes, because the realization of PAD in 2020 was 104.8 billion rupiah, while in 2019 the realization was 114.8 billion rupiah.

Furthermore, for the realization of transfer funds from the central revenue sharing, namely: DAU with DAK decreased by 13.25 percent, or 115.5 billion rupiah, while transfer funds for 2020 were realized at 749.5 billion rupiah, it was down compared to the realization in 2019 which amounted to 864 billion rupiah," he said.

However, according to Hendar, this decline could be helped by the efforts of the Pangandaran Regency Government by boosting the other income sector which is Shah.

For example, the Shah's other income in 2020 increased to 41.49% or 205.7 billion rupiah, compared to 2019.

Meanwhile, the realization of legal other income was 701.6 billion rupiah, while the realization in 2019 was only 495.8 billion rupiah.

Mah, for the revenue post from provincial tax revenue sharing, provincial bankeu, BOS, Village Fund and regional incentive funds, this automatically boosts overall regional income," he explained.

For 2019 regional revenue realized 1.55 trillion rupiah, or 78.4% of the target of 1.98 trillion rupiah.

Meanwhile, when compared to the realization in 2019, it increased by 5.52% or 81.3 billion rupiah, of which the realized regional revenue in 2019 was 1.47 trillion rupiah, from the target of 1.56 trillion rupiah.

However, we also need to be happy, because the realization of regional revenue in 2020 increased by 5.52%, or 81.3 billion rupiah, compared to the realization in 2019," he added. (Anton AS
